Title: 2021 Student Election Complaint Appeals

- Lianna began by reading the complaints against Seong Min Bae.
 - Seong Min Bae gave his 2-minute appeal.
 - Discussion occurred.
 - Lianna clarified this meeting is to decide whether or not the disqualification for Seong Min Bae and Khoa-Nathan Ngo stands.
 - Statements made by Seong Min Bae were read aloud and it was clarified that his conversation was not recorded, thus DASB did not violate Cal. Penal Code (silcrow) § 632.
 - The DASB Senate decided to move forward with Seong Min Bae's disqualification for the 2021-2022 DASB Senate Election.

- Lianna presented the complaints against Khoa-Nathan Ngo and reviewed the sections of the Election code he violated.
 - Khoa-Nathan Ngo gave his 2-minute appeal.
 - Discussion occurred.
 - Senators and prospective senators commented on Nathan's actions and how he violated the Elections code.
 - It was clarified DASB took the correct route in handling this situation.
 - The DASB Senate decided to move forward with Khoa-Nathan Ngo's disqualification for the 2021-2022 DASB Senate Election.
